Who is LNL Consulting?

LNL Consulting is the besloten vennootschap LNL Consulting, with registered office at (1054VZ) Amsterdam listed at the Traderegister of the Dutch Chamber of Commerce under 90703413.

When LNL Consulting processes your personal data, LNL Consulting is the data controller.

How does LNL Consulting use your personal data?

Underneath you will find an overview of the purposes for the processing of your personal data. You will also find a specification of which data LNL Consulting uses for that specific purpose, the legal basis, and the period of time LNL Consulting keeps this data. For clarity's sake, we have categorised the purposes.

Storage period: maximum 1 year

How did LNL Consulting obtain your personal data?

LNL Consulting has obtained your data because you have provided this data to us.

What are your rights?

Under the European General Data Protection Regulation you have a number of rights with regard to your data and the processing thereof:

Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal data LNL Consulting has obtained about you, you may exercise your right of access by submitting a request to LNL Consulting.

Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that LNL Consulting makes these changes for you. You may request that LNL Consulting modifies, corrects, supplements, erases or shields your information.

Restriction of processing of personal data

You also have the right, under certain conditions, to request LNL Consulting to restrict the processing of your personal data.

Right to object

If processing of personal data is based on 'legitimate interest' of LNL Consulting or a third party, you have the right to object to that processing.

Data transfer

You have the right to obtain your personal data from LNL Consulting. LNL Consulting will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems. This will also allow you to transfer your data to another provider.

Withdrawing consent

When the legal basis for a particular processing is your consent, you have the right to withdraw that consent. This does not affect data processed in the past, but it does mean that we are then no longer allowed to process this data in the future. As a result, LNL Consulting may no longer be able to provide you with certain services.

Response from LNL Consulting

A request can be sent to info@lnlinvest.co. LNL Consulting will comply with your request as soon as possible and in any event no later than one (1) month after LNL Consulting has received such a request. If LNL Consulting rejects your request, we will indicate in our reply why the request is rejected.

Recipients of your personal data

LNL Consulting may be obliged to provide your data to a third party, for example on the basis of a legal obligation.

What are cookies and how does LNL Consulting use them?

Cookies are small pieces of (text) information that are sent to your browser when you visit the website of LNL Consulting and then stored on the hard disk or in the memory of your device (hereinafter "Device"). Cookies placed through the LNL Consulting website cannot damage your Device or the files stored on it. When we refer to "cookies", we do not only mean these small pieces of (text) information, but

also similar techniques by which information is collected, such as, for example, device fingerprinting.
